- 2. I understand that ALL tickets are **none refundable**.
- 3. For my and/or child(ren) own safety I confirm I and/or child(ren) weigh equal to or below **120kg**, and reach a height of at least **1.4m** to for the Hawks View & Flying Fox Zip or reach a height of at least **1m** and at least **5yrs** old for the Monkey Trail, Crazy Climb & Plummet.
